

## Ubuntu Global Connections Statement of Privacy.

Ubuntu Global Connections is committed to protecting your privacy. This Statement of Privacy applies to Ubuntu Global Connections Web site and governs data collection and usage at all Ubuntu Global Connections sites and services; it does not apply to other online or offline sites, products or services.
